- Present a user-intuitive menu system and navigation framework


- Provide a repository of documents and forms for distribution to various stake holders, including:

It's Board Election Time Again. Consider Getting Involved!

Annual Election and 2020 Budget Meeting Notifications & Requirements

NRS 116 REQUIRES NOTICE be given to each unit's owner of their eligibility to serve as a member of the executive board (aka: board of directors). Such notice shall be given not less than 30-days before

the preparation of a ballot. The Annual Election and 2020 Budget Ratification packet contains a plethora of documents and notifications; the majority of which are required by NRS.

In order to fulfill the eligibility notification requirements, the Candidacy Disclosure Statement (CDS) provided by the NV Real Estate Division is included in this edition along with an Annual Election Solicitation. This Caughlin Rancher edition was scheduled to publish on September 18th and expected to be received by local unit owners by September 20th. The CDS must be returned by 5:00 p.m. on Friday, October 18th in order for the candidates' name to be placed on the secret ballot, if a ballot is required. This process is explained further in the Annual Election Solicitation on page 15.

Please take the time to review the Annual Election and 2020 Budget Ratification packet AS SOON as it arrives. If there is a Secret Ballot enclosed, there will be a Candidate Forum on Wednesday, November 6th

and the deadline to return the secret ballots will be 12:00 noon on Monday, November 18th. If there is the need for an election, the Annual Election and 2020 Budget Ratification Meeting will convene at 1:00 p.m. on Monday, November 18, 2019 for the sole purpose of opening and tallying the secret ballots. Whether there is an election or not, the Annual Election and 2020 Budget Ratification Meeting will begin at 6:30 p.m. on Wednesday, November 20, 2019.

Agenda Workshops are held on Mondays and General Business Meetings of the Board of Directors on Wednesdays every other month in January, March, May, July, September, and November. A Budget Workshop is held in August and Board Training in December. An Executive Session of the Board is held prior to each Board Meeting. Board Members are encouraged to participate on standing committees.

NRS 116.31034 states in part:

"7. If, at the closing of the prescribed period for nominations for membership on the executive board, the number of candidates nominated for membership on the executive board is less than the number of members to be elected to the executive board at the election, the executive board may fill the remaining vacancies on the executive board by appointment of the executive board at a meeting of the executive board held after the candidates are elected pursuant to subsection 5. Any such person appointed to the executive board shall serve as a member of the

executive board until the next regularly scheduled election of members of the executive board. An executive board member elected to a previously appointed position which was temporarily filled by board appointment pursuant to this subsection may only be elected to fulfill the remainder of that term."

NRS 116.31034 has new provisions that became effective on October 1, 2015. "A person may not be a candidate for or member of the executive board or an officer of the association if: (1) The person resides in a unit with, is married to, is domestic partners with, or is related by blood, adoption or marriage within the third degree of consanguinity or affinity to another person who is also a member of the board of directors or is an officer of the association; (2) The person stands to gain any personal profit or compensation of any kind from a matter before the board of directors of the association. ..."

...any CRHA member who has outstanding assessments, fines, construction penalties and/or unresolved violations of the governing documents (as determined in a compliance hearing), shall not be eligible to cast a vote in an association election.

NRS 116.31031 "Power of executive board to impose fines and other sanctions for violations of governing documents; limitations; procedural requirements; continuing violations; collection of past due fines; statement of balance owed.

- 1. Except as otherwise provided in this section, if a unit's owner or a tenant or an invitee of a unit's owner or a tenant violates any provision of the governing documents of an association, the executive board may, if the governing documents so provide:
- (a) Prohibit, for a reasonable time, the unit's owner or the tenant or the invitee of the unit's owner or the tenant from:
- (1) Voting on matters related to the common-interest community. ..."

Therefore, please be advised that any CRHA member who has outstanding assessments, fines, construction penalties and/or unresolved violations of the governing documents (as determined in a compliance hearing), shall not be eligible to cast a vote in an association election.

WHEN LORRAINE HOWARD WAS GROWING UP, her dad, a former elementary school principal, used to tell her, "If you ever have an opportunity to take kids along with you, do it."

Howard, a native of the Reno-Tahoe area, took her dad's advice to heart — she's built a career introducing children of *all* ages and abilities (particularly those who otherwise would not have access) to adventures in sports and physical activity.

EXERCISING COMPASSION

"I knew I'd be a PE teacher my whole life, just from my upbringing," Howard says, explaining that even as a 14-year-old, while most of her peers were at the mall, she was teaching dance and gymnastics classes to low-income kids at the local YMCA.

She completed both a Bachelor of Science in medical sciences in 1981 from the University of Nevada, Reno, and, feeling drawn to physical education, a Bachelor of Science in PE, recreation and dance at UNR in 1983 while teaching PE for one year with the Washoe County School District (WCSD).

Then, she says, she was "called" to work at the Job Corps, helping roughly 2,600 kids earn the PE credits they needed to graduate from high school. She then went on to expand her repertoire, earning her Master of Education in curriculum and instruction in secondary education at UNR in 1998.


Howard later returned to the school district, where for 23 years she has combined her passions for both PE and students with special needs for her position as WCSD's adapted PE specialist.

Routinely, Howard visits 16 schools in the district to provide PE instruction to students receiving special education services, ages six and up. Activities vary. Her curriculum includes lead-up sports, cooperative games, developmentally appropriate exercise and fitness progressions and concepts, exposure to outdoor recreation and sampling individual recreational pursuits.

Unlike general education teachers who work with each student only one school year, Howard has the benefit of following students throughout school, forming relationships with them and watching them blossom.

"I give kids chances to help me by being my teaching assistant or equipment manager, and they learn things such as how to set up the obstacle courses with me. I have the ability to mentor kids from first grade to graduation, and that's appealing to me."

Always looking for ways to make physical activity enjoyable for all, she realized a few years ago that for some students, she needed a device that could keep them afloat in the water without requiring her to physically hold them up. She became a project sponsor for two projects in the UNR Senior Systems



Design Project in the mechanical engineering program and tested students' abilities with designing the Adapted Swimming Device (ASD), which provides a swimmer who has coordination issues, independence in the water. Another team of five seniors collaborated with her to create a wheelchair with snap-on wheels that allowed a family flexibility in taking a child with mobility challenges along on their outdoor adventures.

"I learned so much working with those engineering students that I decided this year to be a teacher mentor," Howard says. This fall, she will serve as a volunteer course instructor for the UNR Department of Special Education in Assessment of Pupils for Adapted PE course, in which she'll mentor graduatelevel teachers.

NEW ADVENTURES

Howard's newest project is the Reno Pop Warner Challenger league, the first of its kind in our area. The program enables kids ages six to 18 to practice and play no-tackle flag football in a safe, supportive environment. The program kicked off in August with 15 athletes who have never before played flag football; it involved six one-hour practice sessions and culminated in a September game.

The program uses a peer tutor/mentor method of instruction with sequenced motor skills training. She's

currently on the hunt for young people who can volunteer for future sessions. Facilitating peer interaction/cooperative learning, she says, is her preferred teaching method.

In fact, she's used it for years in her adaptive PE class. She points to the yearly anti-bullying dance program she has her students produce each year, in which 15 special education students work with 30 peer tutors over the course of eight weeks to execute dance numbers about friendship and inclusion.

"It's called Best Friends = No More Bullies. The premise is that when you're in elementary school, you'll meet and befriend a special child, and you'll go all the way through school with that child and be his or her friend, and you'll go to birthday parties and support them," Howard says, adding that it's been a core belief practiced in her own home, with her own children having grown up this way. "I feel it's a life-changing project because kids can develop empathy and compassion for children who learn differently."

SPIRIT OF VOLUNTEERISM

A prouder parent than Howard, you'd be hard-pressed to find. Daughter Giselle, 31, spent her 20s teaching yoga and volunteering throughout Asia and becoming fluent in five languages, eventually returning last year from India with her 2-year-old daughter in tow to live with her mother in Caughlin Ranch.



The Reno Pop Warner Challenger League is looking for volunteers to work with athletes as one-on-one tutors. Volunteers must be at least age 13, possess a desire to be a positive role model and commit to being on the field during practices and games for the entire season. "My whole life I lived within three miles of Caughlin Ranch, and I always wanted to live there," Howard says. "When I bought my three-story current house 10 years ago, my intention was that my three adult children would have children and come back between adventures and be able to live with me!"

Howard's daughter Tennille, 30, works as the supply chain hiring manager at Reno's JCPenney Distribution Center, coordinating massive volunteer efforts through her workplace and in the community.

Her son Chase, now 29, is an endurance athlete and member of the U.S. Army who earned the Soldier of the Year award in 2015 from the Nevada National Guard. He not only delivered free swimming lessons for five years through his mother's adapted aquatics program for middle and high schoolers, but

he once volunteered to help one of Howard's Caughlin Ranch neighbors whose roof blew off during a violent storm — he scaled the side of the house and promptly laid down a tarp and sandbags to cover the hole.

And although they're all grown with lives of their own, Howard's home always is bursting with life and love for her community. In fact, during the Caughlin Fire of 2011, the Howards opened their home to firefighters, and it became a center for photo/film media operations.

"When you raise your children to volunteer, when you have that attitude instilled in you, it's the most important thing a parent can do for a child," she says. "I think it forces you to extend yourself and your capabilities, and you quickly learn that you're way more powerful than you ever thought you were."

ESI NEIGHBORHOOD PATROLS

ESI began conducting community patrols for a period of 18-weeks on Friday, June 28th, and will continue through Monday, October 28th. They are onsite four days per week; Friday, Saturday, Sunday and Monday from 10:00 p.m. to 4:00

ESI has been asked to provide two patrol vehicles on Thursday, October 31st (Halloween) from 10:00 p.m. to 4:00 a.m. Every night at approx. 10:00 p.m., ESI closes off access to the Village Green Park parking lots; ESI re-opens them at approx. 4:00 a.m.

ESI is also conducting Trail Patrols one day per week on alternate days (Monday through Saturday) from 6:00 a.m. to 10:00 a.m. They greet handlers of off-leash dogs, remind them of the CRHA rules and Washoe County ordinances while handing them a flier noting both.

Off leash dogs is a major problem throughout Caughlin Ranch that unfortunately, is impossible to control.

TRASH/RECYCLE CONTAINERS AND WILDLIFE

Is it absolutely true that Caughlin Ranch residents ARE NOT **ALLOWED** to place their trash containers out for pick-up prior to Tuesday morning. That is the rule, and CRHA is enforcing it consistently and on a regular basis throughout the community.

We know how early Waste Management generally arrives in the morning. We know some of our residents are retired

and prefer not to set an alarm to get up early to put out a trash container. We know it can be icy in the morning during the winter months. We know many residents have never seen a bear in Caughlin Ranch. We know following the rule can sometimes be a burden and a hassle particularly if you are planning time away on trash day which is Tuesday.

On a nightly basis, Caughlin Ranch has several animal species wandering about and rummaging for food; bears, raccoons, coyotes, marmots, and lynx to name a few. And yes, they travel and cross both sides of McCarran Blvd. They move along the trails just as we all do.

You can easily avoid receiving a written notice from Caughlin Ranch by not placing your trash or recycle container out for pick-up prior to Tuesday morning and by storing them back out of sight by Tuesday night. If you are going to be away from home during that time, please ask for assistance from a neighbor, friend or family member in order to avoid the need for a written notice. The Board of Directors does not grant waivers or variances to neighborhoods, individuals or businesses regarding the placement or storage of trash and/or recycle containers.



PLEASE BE REMINDED THAT THE MAXIMUM SPEED LIMIT ON CITY AND COUNTY STREETS AND ROADS WITHIN **CAUGHLIN RANCH IS 25 MILES PER** HOUR.

PONDS & WATERWAYS

Swimming and wading are strictly prohibited. At this time, only catch and release fishing is permitted. Never toss or throw anything into the ponds or waterways since there are turtles, fish, crawdads, etc. which reside there all year round. Never attempt to hold, harass or remove any turtles, fish, crawdads, etc. from the ponds or waterways.

STOLEN MAIL AND DAMAGED MAIL BOXES

Stolen mail is being reported regularly in Caughlin Ranch. Thieves are using small tools to break into locked boxes. The U.S.P.S. recommends establishing an account on their website and signing-up for "Informed Delivery".

What is Informed Delivery®? Informed Delivery is a free and optional notification feature that gives residential consumers the ability to digitally preview their letter-sized mail and manage their packages scheduled to arrive soon. Informed Delivery benefits the entire household by allowing users to view what is coming to their mailbox whenever, wherever — even while traveling — on a computer, tablet, or mobile device.

PROPOSED 2020 BUDGET

The proposed 2020 budget will be ratified at the November 20th Annual Election Meeting, subject to owner/member ratification.

Noteworthy issues regarding the Proposed 2020 Budget include the following:

1. Once again there is no proposed assessment increase in 2020. The last assessment increase in 2017 followed a stretch of nine years without an increase. This fiscal success was the result of stringent budget controls and a significant reduction in irrigation costs through a program of low water landscaping combined with the

- water project which saved over \$200,000 last year alone.
- The strong CRHA cash position will allow us to pay down a portion of the building mortgage in 2020. We have budgeted \$75,000 for this purpose which would save the Association approximately \$33,000 in interest payments over the remaining life of the loan. The actual amount of the pay down will be determined in the first quarter of 2020 when our 2019 year-end cash position is confirmed (we have the ability to pay down less than the approved budget amount but not more).
- Looking beyond 2020, one factor that will impact future budgets and assessments is the cost of our landscape labor force. The labor market in Reno is extremely tight due to the high level of economic development throughout the region. This has necessitated a substantial increase in wages over the past several years to attract and retain a seasonal landscape crew. We expect this trend to continue.

We welcome your comments and questions and look forward to seeing you at the November 20th Annual Spaghetti Feed and 2019 Annual Members Election and 2020 Budget Ratification Meeting.

Well folks, it finally happened! Both the City of Reno and Washoe County's Franchise Agreements with Waste Management have been finalized to include the distribution and servicing of ANIMAL-RESISTANT CONTAINERS for residents in bear-prone areas.

If you are interested in obtaining an animal-resistant container, please contact Waste Management at (775) 329-8822; press prompt 4 and then 4 again. There is a premium charge to service the container since the driver must exit the vehicle to unlatch the container. However, the greater benefit to our Caughlin Ranch residents is that they are permitted to







BAND FUNDRAISER



Tickets will be on sale in September or you can donate silent and live auction items to huskieharvest@gmail.com. Wine will be Sponsored by Whispering Vine.






Have you ever driven down Mayberry Drive, just east of McCarran and wondered what's going on next to the old Garden Shop Nursery? It looks like someone has started an urban garden, but what exactly are they doing with the space?

I noticed that Lyndsey Langsdale had been posting on nextdoor.com about their Farmer's Market at the "Park Farm" on Mayberry Drive, so I did some digging (pun intended).

Turns out, according to a story published in edible Reno-Tahoe's Winter 2018 edition, "Langsdale, 36, manages the five-acre education and demonstration farm at Betsey Caughlin Donnelly Park for Reno Food Systems, a nonprofit dedicated to cultivating community food systems through education, research, and civic engagement. With a lease and land use agreement with Washoe County Regional Parks and Open Space, the Park Farm is being developed as a teaching campus for novice farmers. The summer of 2018 was the inaugural season for the program, offering handson training, education and mentorship for four interns. The goal is to take on four new interns each year while continuing to support the efforts of its graduates who, in turn, will mentor those following behind them and who will eventually move on to develop their own agriculture projects on other parcels of underutilized public
