
AS-IS STANDARD FOR THIS TIME OF YEAR, our seasonal workforce commenced landscape activities on Monday, April 6, 2020.



BEARS & BIRD FEEDERS

Did you know they are a major bear attractant? A bear will climb over a fence, up a tree and onto a roof to get to food. We have photos! Bird feeders, seed and liquid, should be removed at dusk in order to minimize the chance of an unexpected visitor. The NV Division of Wildlife (NDOW), recommends spreading the seed on the ground. The birds will still come but the bears will not bother.

POLITICAL SIGNS

The Revised Rules & Regulations state: "Political signs may be displayed on an owner's Lot subject to any applicable provision of law governing the posting of political signs and under the following guidelines. A political sign is a sign that expresses support for or opposition to a candidate, political


party or ballot question in any federal, state or local election or any election of an association. Political signs shall not: exceed twenty-four by thirty-six inches (24" by 36") in size, be posted on any common area, or be electronic or lit-up. Political signs shall be posted and removed in accordance with the applicable local ordinances. Only one (1) political sign may be posted for each candidate, political party or ballot question. Political signs must also comply with the adopted Guidelines and Policies (CC&R's Article III, H, #1)."

STATE PRIMARY ELECTION—VOTE BY MAIL!

CRHA was slated to serve as a polling place for the state primary scheduled for June 9th. Due to our current state of affairs, primary voting will be conducted strictly by mail-in ballot. Remember, no mater how you vote or for whom you vote, it is important to exercise your right to vote!

TRASH AND RECYCLE CONTAINERS

The Revised Rules & Regulations state: "Solid waste trash/garbage shall be properly contained before it is placed into the trash receptacle and the lid shall be properly closed so that trash cannot spill out



or become wind-blown. Solid waste trash/garbage shall not be placed or stored outside the trash receptacle. Properly bagged yard clippings and landscaping debris may be stored outside the trash receptacle; HOWEVER, due to COVID-19, Waste Management has suspended curbside collection of bagged excess waste, but it is **expected to resume in mid-June.** In the meantime, you can bring your excess waste to a local Waste Management transfer station or Lockwood Regional Landfill for disposal. Remember to use your included annual dumps or excess waste stickers for free disposal. Please go to WM.com/alerts for more information.

Trash receptacles and recycle bins shall be stored in such a manner that the containers are screened from view except when the containers are within the collection area for pick-up. Owners and residents WITH approved "animal-resistant" trash containers may place their garbage and recycling containers in the collection area for pick-up the evening before pick-up.

Owners and residents WITHOUT approved "animal-resistant" trash containers shall be required to place their garbage and recycling containers in the collection area for pick-up the morning of pick-up. All garbage and recycling containers shall be removed from the collection area no later than the evening of the pick-up day. Waste Management offers a pick-up service, at no additional charge, to verifiably disabled and elderly residents. This includes pick-up of "animal-resistant" containers.

The Washoe County Health District requires homeowners acquire an animalresistant container after two (2) violations within one (1) year or less when an animal gains access to the trash. Caughlin Ranch will report these incidents to the Washoe County Health District (CC&R's Article III, J)."

PLEASE do not place your trash or recycle container out for pick-up prior to Monday morning.

TMWA ASSIGNED-DAY WATERING

Know your assigned days. If the last number of your home or business address is:

Even (0, 2, 4, 6 or 8), you may run the sprinklers on Tuesdays, Thursdays and Saturdays.

Odd (1, 3, 5, 7 or 9), you may run the sprinklers on Wednesdays, Fridays and Sundays.

Watering Times: Normally, we ask that you shut your sprinklers off between noon

A Plea to Caughlin Ranch Dog Walkers

IN THE TWO YEARS I'VE BEEN WALKING MY DOG IN CAUGHLIN RANCH, I've noticed an increasing number of dogs off leash. Perhaps not coincidentally, there is also an increasing amount of dog feces. All this is despite the widespread signs that neither practice is acceptable.

While serving terms on both the Caughlin Ranch and Caughlin Creek boards, I have been approached by more than one homeowner begging for intervention. While I am not personally threatened by big dogs off leash, owning one and having grown up with them, I am sensitive enough to my fellow neighbors to recognize that some people have a visceral fear of big dogs, either for themselves personally or for their small dogs being walked.

For those of you who insist that your dog is well behaved and/or wearing a radio collar, I offer the argument that you set a bad example for those owners who have neither attribute in their dogs. They see it as encouragement to ignore the signs and let their dogs run free, jeopardizing the experience for others.

Much as I would like to let my water-loving dog run free, in and out of the plentiful bodies of water we have in the Ranch, I don't do so for two reasons: 1) My dog groomer has said they have seen more than one Caughlin Ranch dog with fungus infections from the waters here. 2) I believe when you live in a planned community with rules, you should abide by them.

We tried to create a dog park where dogs could run free in Caughlin Ranch while I was on that board, but it was vetoed by the Village Green homeowners because of traffic concerns. There are, however, other dog parks in Reno, three within five miles of here.

I know some people think this aberrant behavior is all from outsiders, about whom we have little control. However, I know from the times and locations I walk my dog, and lack of parked cars on Caughlin Ranch Pkwy., that this is residents ignoring the signs.

I believe that if we can't get more compliance with the rules, we should remove the signs and abandon the paths to those who dare. As in parenting, organizations who have rules they don't/can't enforce invite non-compliance.

and 6 p.m. from Memorial Day through Labor Day to conserve water.

Also, give your sprinklers a rest on Mondays, as this is a day, we replenish our water system.

Outdoor watering increases water use of the average residential customer by up to 10 times during the dry summer months. Beyond the clear conservation benefit, assigned-day watering also helps to level off peak usage during the highdemand season.

Caughlin Ranch is considered a commercial property giving us the ability to water on different days and times. On Mondays, we give the irrigation systems a rest and mow, mow, mow.

STREETLAMP OUTAGES

Please report any outages directly to NV Energy at www. nvenergy.com/outages-and-emergencies/streetlight/reportissue. There is a number on the underside of the lamp that identifies its location. If you are out in the evening and notice a lamp out, count the number of poles from the nearest intersection and any landmarks to better identify the location and take a photo of the underside of the lamp with your cell phone if you can.
