#### **1. Call to Order at 12:00 noon on Monday, November 17, 2025**

GM Nunley called the 2025 Annual Election to order at 12:00 noon for the purpose of counting the annual election ballots.

#### **2. Appointment of Inspector of Elections; Identify Member Volunteers to Open and Tally Secret Ballots**

Homeowner Volunteers present to count ballots and confirm electronic voting tally were Carol Pallesen and Joyce Thompson. The Inspectors of Election form was signed by all present. Also in attendance was Asst. Mgr. Sandy Wheeler.

#### **3. Open and Tally Secret Ballots (both electronic and hardcopy ballots)**

Homeowner Volunteers opened and tallied the ballots.

There being no further current business, the meeting was recessed at 12:30pm.

#### **5. Reconvene & Welcome from Board Vice President/Acting President, Wednesday, November 19, 2025**

VP Ginsburg reconvened the 2025 Annual Members & Election and 20265 Budget Ratification Meeting at 6:36pm.

#### **6. Member Comments: This time is devoted to Association Members who have comments and/or concerns regarding any Association matter.**

Except in the case of an emergency, no action may be taken upon a matter raised under this item of the agenda until the matter has been specifically included on an agenda as an item upon which action may be taken. The Board has the authority to limit the time for individual comments. A time limit of two (2) minutes per member has been allotted. No member can give

away his or her allotted time to expand another member's time. In consideration of other members who may wish to present comments and/or concerns, please avoid repetition.

- A homeowner asked the Board to continue to evaluate the budget to maintain the level of assessments. He also relayed that there is heavy traffic in the "circle drive" by the elementary school. Can the Board ask the city to install traffic calming.
- A homeowner commented that the flashing lights by the school don't work. Staff noted that this belongs to the City of Reno and a message can be sent to them via Reno Direct. Staff will also follow up.
- A homeowner who lives in the Cottages asked if a light can be installed on Caughlin Pkwy at the crosswalk by the Cottages. Director Miller provided an update on his efforts to reduce speeding on the Parkway. He is working with the City of Reno Police Dept regarding speeding on Caughlin Pkwy and Village Green Pkwy and hopes for allocation of funds for traffic calming efforts.
- A homeowner commented about a blind curve on Village Green Pkwy. Can additional signage and traffic calming be installed.
- A homeowner commented that he hears shooting above Pinehaven. A brief discussion ensued about the Association's efforts to report illegal behavior in this area.
- A homeowner agreed that blinking pedestrian lights would help on the Parkway, especially with all the wildlife. She reminded those in attendance to not feed the geese.
- A homeowner asked if trees along the pathways could be trimmed up. He was encouraged to contact the office with the specific locations.

**8. Approval of November 20, 2024 Annual Members Election & 2025 Budget Ratification Meeting Minutes**

**MOTION:** Homeowner T. Laird moved to approve the minutes of the November 20, 2024 Annual Members Election & 2025 Budget Ratification Meeting Minutes as presented; Homeowner R. Weaver seconded. Motion unanimously carried.

**9. Announce Results of 2026 Operating and Reserve Budget Ratification; Assessment Increase of Seven Percent (7%)**

VP Ginsburg provided brief comments regarding the assessment increase for 2026 and provided the following statement regarding Budget Ratification.

NRS 116.31151 § 3. states: "...Unless at that meeting a majority of all units' owners, or any larger vote specified in the declaration, reject the proposed budget, the proposed budget is ratified, whether or not a quorum is present. If the proposed budget is rejected, the periodic budget last ratified by the units' owners must be continued until such time as the units' owners ratify a subsequent budget proposed by the executive board."

Therefore, because a majority of the units' owners did not attend to reject the 2026 budget, it is considered ratified.

**10. Announce results of 2025 Annual Election of Directors; four (4) Board Members will be seated (three 2-year positions; one 1-year position)**

VP Ginsburg reported that, for this year's elections, there were four (4) Board Member positions available, three 2-year positions and one 1-year position. Elected to the Board are: Steve Bremer, Al Dennis, Mike Ginsburg and Jeanne Naccarato.

VP Ginsburg also announced that, at this week's Board Meeting, Allen Black was appointed to fill the one-year vacancy caused by Thomas Keiffer's resignation.
